Citizens must complete a **Request to Speak Form** before the meeting. Citizens will be able to have one (1) question/comment at this time. The council cannot respond to any questions/comments. The mayor will make an appt to answer your question, or it will be considered as an agenda item for the next city council meeting. Your name will be called at the appropriate time during our Public Comments. **Please step forward to the stand to address the council. Comments must be directed to the Council as a whole.**

- **CALL MEETING TO ORDER** Mayor calls the Meeting to order, states the date and time, states Councilmembers present, and declares a quorum present.****
- **CITY SECRETARY TO ADMINISTER OATH OF OFFICE** Mayor Karen DeLoney, Council Member Clint Jones, and Council Member Peggy Smith. Texas Government Code Section 602.002 lists multiple positions that carry the power to administer the oath of office. They include, among others: a judge, retired judge, or clerk of a municipal court or court of record, as well as a senior judge or commissioner of a court of record; a justice of the peace or clerk of a justice court; a notary public; a legislator or retired legislator; a peace officer, if the oath is administered when the officer is engaged in the performance of his duties and the administration of the oath relates to his duties; and a city secretary or city clerk in a matter pertaining to the official business of the city. TEX. GOV'T CODE §602.002
- **AUDIO/VISUAL EQUIPMENT** Citizens are allowed to record city council meetings, however there will be a designated location for all audio/visual equipment.
