CITIZENS COMMENTS/REQUEST TO SPEAK ON AGENDA ITEMS (3) MINUTES Questions about any one of the Council Agenda items may be taken into consideration during the agenda item. Comments are limited to three (3) minutes per individual. Citizens must complete a **Request to Speak Form**. Citizens will be able to have one (1) question per Agenda item. Speaking time is not transferable. The mayor will call your name at the appropriate time. **Please step forward to the stand to address the council. Comments must be directed to the Council as a whole. If you do not step forward, your right to speak will be forfeited.**

PUBLIC DISCUSSION Citizens may address the city council on any other subject during the **Public Discussion**. Comments are limited to three (3) minutes. Citizens must complete a **Request to Speak Form**. Citizens will be able to have one (1) question/comment during the **Public Discussion**. The Mayor will call your name at the appropriate time during our Public Discussion. **Please step forward to the stand to address the council. Comments must be directed to the Council as a whole. If you do not step forward, your right to speak will be forfeited.** What may members of a governing body do if an unposted issue is raised at an open meeting? Members of the governing body **may not** deliberate or make any decision about an unposted issue at a meeting of the governing body. If an unposted item is raised by members or the general public, the governing body has four options. First, the mayor may respond with a statement of specific factual information or recite the governmental body's existing policy on that issue. Second, the mayor may direct the person making the inquiry to visit with staff about the issue. Third, the governing body may offer to place the item on the agenda for discussion at a future meeting. Finally, the mayor may offer to post the matter as an emergency item if it meets the criteria for an emergency posting. (See Section VI for a discussion on emergency meetings.)

- **CALL TO ORDER:** Mayor to call the meeting to order, announce the date and time, identify councilmembers present, and declare a quorum.
- **INVOCATION**
- **APPROVAL OF MINUTES:** Review and Approval of the Minutes from the previous meeting.
- **FINANCIAL REPORTS:** Year-to-Date Financial Statements through September 2025.
- **ORDINANCE: REGARDING 2025 TAX RATE:** Consideration and approval of an ordinance adopting the previously approved 2025 property tax rate of \$0.25 per \$100 of taxable value.
- **CR 4084 – TREE LIMB REMOVAL:** Discussion and action regarding pricing for removal of a dead tree limb.
- **CITY ROAD MAINTENANCE (CR 4083 & CR 4084):** Discussion on road maintenance for CR 4083 and CR 4084. Maintenance of ditches as needed. Approval of resident notification letter regarding maintenance responsibilities.
